

IMPORTANT FORM FOR IDENTIFYING YOUR HIGH VALUE INVENTORY

WE HAVE ENCLOSED A HIGH VALUE INVENTORY FORM FOR THE PURPOSE OF ASSISTING YOU IN IDENTIFYING YOUR ITEMS OF EXTRAORDINARY VALUE. THIS FORM *MUST* BE COMPLETED PRIOR TO YOUR PACK DAY AND PRESENTED TO YOUR DRIVER PRIOR TO PACKING OR LOADING OF YOUR GOODS. IF THERE ARE NO ITEMS EXCEEDING \$100.00 PER POUND IN YOUR SHIPMENT, SIMPLY WRITE "NONE", SIGN THE FORM AND HAND IT TO THE DRIVER.

A SHIPPER'S FAILURE TO NOTIFY THE CARRIER OF ARTICLES THAT HAVE A VALUE THAT EXCEEDS \$100.00 PER POUND AND WILL BE INCLUDED IN THE SHIPMENT, WILL LIMIT THE CARRIER'S MAXIMUM LIABILITY TO \$100.00 PER POUND FOR EACH POUND OF ANY LOST OR DAMAGED ARTICLE (BASED ON ACTUAL ARTICLE WEIGHT), NOT TO EXCEED THE DECLARED VALUE OF THE ENTIRE SHIPMENT. THE PURPOSE OF THIS INVENTORY IS TO ASSIST YOU IN IDENTIFYING ARTICLES OF EXTRAORDINARY OR UNUSUAL VALUE IN ORDER THAT THE CARRIER WILL BE AWARE OF THOSE ITEMS WHICH REQUIRE SPECIAL HANDLING AND PROTECTION.

FAILURE TO IDENTIFY SUCH ARTICLES WILL RESULT IN LIMITED CARRIER LIABILITY.

IF THROUGH INADVERTENCE OR ANY OTHER CAUSE, ITEMS HAVING A VALUE IN EXCESS OF \$100 PER POUND PER ARTICLE ARE INCLUDED IN YOUR SHIPMENT AND YOU FAIL TO LIST THOSE ITEMS ON THIS INVENTORY, OR FAIL TO SIGN THIS INVENTORY, YOU EXPRESSLY AGREE THAT THE CARRIER'S LIABILITY FOR LOSS OR DAMAGE TO THOSE ITEMS WILL BE LIMITED TO NO MORE THAN \$100 PER POUND PER ARTICLE (BASED UPON THE ACTUAL ARTICLE WEIGHT).
